

The Banking Agency of the Federation of BiH is publishing a

PUBLIC CALL

for submission of offers for purchase of a business building/ premises

1. The description of the procurement subject

A business building as a free standing construction - a separate business building or business premises within an independent business building, in compliance with the economic-financial, property-legal, technical and other requirements listed in the documentation for the tender.

2. The right for participation in the bidding process

All the bidding parties who own the property which is the subject of the bid.

3. Participation conditions and needed evidence

In order to be able to participate in the procurement procedure, the bidding party should fulfill certain conditions and submit needed evidence, as it is listed in the documentation for the bidding process.

4. Deadline for submitting the offers

The deadline for submitting the offers in regard to this bidding subject expires on 30. 05. 2013., at 16:00.

5. Contract appointment criteria – bid evaluation

The contract shall be appointed to a qualified bidding party, based on the criteria of the economically most favorable offer, with the implementation of the following sub-criteria, in a descending order:

- a) The offering price of the completely functioning building/premises which is the subject of the purchase/sale agreement: 70 points
- b) Construction quality/esthetic and functional characteristics of the building/premises: 15 points
- c) Location/convenience of the location: 10 points
- d) Delivery deadline: 5 points

6. Documentation for the bidding process

Can be downloaded from the Banking Agency of the Federation of BiH website: <u>www.fba.ba</u> (PDF format) or in the business premises of the Agency (the protocol), during the working days from 10,00 to 15,00, free of charge.

The bidding party which downloads the documentation from the website of the Agency, is obliged to submit their data (title, head office, contact person, fax number or an e-mail address) by mail to the address of the Agency or by fax, number: 033 66 88 11, in the case additional information and explanation need to be provided.

7. Submitting the bids

The bid needs to be submitted in an enclosed envelope which is not transparent, with a signature and seal of the offering party, title/name and address of the bidding party, by mail or in person to the address: Banking Agency of the Federation of BiH, Sarajevo, Koševo 3, with a note: «Bid in regard to the public call for purchase of business building/premises – do not open».

If the bid is submitted after the end of the deadline determined for submitting the bids, the same will not be considered and will be returned to the bidding party unopened.

8. Public opening of the offers

At the business premises of the Banking Agency of the Federation of BiH (the conference room), Sarajevo, Koševo 3, as stated in the documentation for the bidding process. The authorized representatives of the bidding party with a written consent, can be present at the opening of the bids.

9. Other

The bidding parties will be informed about the results of the procedure for the appointment of the contract latest within 7 (seven) days from the day the decision is made about the choice of the most favorable bidding party.
