INFORMATION INDEX REGISTER UNDER CONTROL OF THE BANKING AGENCY OF THE FEDERATION OF BOSNIA AND HERZEGOVINA

I.

The Index Register provides the information under the control of the Banking Agency of the FBiH (hereinafter: the Agency), in accordance with the Freedom of Access of Information Act for the Federation of Bosnia and Herzegovina and the Guide for Access to Information.

II. Types of Information

The information under the control of the Agency are as follows:

- 1. Information from the records kept by the Agency on banks, micro-credit organizations, leasing companies and factoring companies or institutions for which the Agency issuing the operating license, as well as on organizational parts of these institutions operating in the Federation of Bosnia and Herzegovina and having their headquarters in Republika Srpska.
- 2. Information on the banking system of the Federation of Bosnia and Herzegovina
- 3. Information on the organization and activities of the Agency, including information on the Ombudsman for the banking system of the Federation of Bosnia and Herzegovina
- 4. Information on plan and implementation of public procurements,
- 5. Information on cooperation of the Agency with other bodies and organizations,
- 6. Providing opinions on the application of the provisions of the laws regulating operations of the institutions supervised by the Agency, and providing interpretation of the regulations issued by the Agency
- 7. Other information under the competence of the Agency.

III. Type and availability of the information

Information under point I-1 of the Index Register are partially available on the website of the Agency, and information not published on the website may be obtained by submitting a request for access to information, provided that there are no restrictions under the regulations governing protection of personal data and confidential information and under reasons referred to in part of the Agency's Guide for Access to Information which relate to the exception to the right of access to information.

Information under point I-2 of the Index Register are available on the website of the Agency or by submitting a request for access to information.

Information under point I-3 of the Index Register are partially available on the website of the Agency, and may be also obtained by submitting a request, provided that there are no restrictions under the regulations and protection of personal data and confidential information and under reasons referred to in part of the Agency's Guide for Access to Information which relate to the exception to the right of access to information

Information under point I-4 of the Index Register are available on the website of the Agency or by submitting a request for access to information.

Information under point I-5 of the Index Register may be obtained by submitting a request for access to information, provided that there are no restrictions under the regulations on protection of personal data and confidential information and under reasons referred to in part of the Agency's Guide for Access to Information which relate to the exception to the right of access to information.

Information under point I-6 and I-7 of the Index Register may be obtained by submitting a request for access to information, provided that there are no restrictions under the regulations on protection of personal data and confidential information and under reasons referred to in part of the Agency's Guide for Access to Information which relate to the exception to the right of access to information.

Where upon the request for access to information, the Agency is unable to provide information because the access was restricted by law in whole or partially or does not have data at its disposal, nor it has been authorized to keep records, where possible it shall address the applicant to the entity which is the source of information.

Index Register forms an integral part of the Guide for Access to Information, within the meaning of the provisions of the Freedom of Access of Information Act for the Federation of Bosnia and Herzegovina (Official Gazette of the FBiH, no: 32/01 and 48/11).
